CITY COUNCIL ORDINANCE NO. 2012-2024

AN ORDINANCE OF THE CITY OF LAKE CITY, FLORIDA, AMENDING AND RESTATING SECTION 2-354, ARTICLE VIII OF CHAPTER 2 OF THE CODE OF THE CITY OF LAKE CITY; PROVIDING FOR THE CITY MANAGER AND CITY FINANCE DIRECTOR TO BE AUTHORIZED AND EMPOWERED DURING ANY FISCAL YEAR TO TRANSFER AND REALLOCATE FUNDS WITHIN ANY DEPARTMENT BUDGET AS AUTHORIZED BY THE PROVISIONS OF THE CITY CODE AND FLORIDA STATUTES, OTHER THAN FOR CAPITAL EXPENDITURES AND SALARY ACCOUNTS; PROVIDING FOR A FISCAL YEAR FOR THE CITY; PROVIDING FOR THE REPEAL OF ALL ORDINANCES IN CONFLICT WITH ANY OF THE PROVISIONS OF THIS ORDINANCE; PROVIDING FOR A SEVERABILITY CLAUSE; PROVIDING FOR THE INCLUSION OF THIS ORDINANCE IN THE CITY CODE; AND PROVIDING FOR AN EFFECTIVE DATE.

NOW, THEREFORE, BE IT ENACTED BY THE PEOPLE OF THE CITY OF LAKE CITY, FLORIDA, AS FOLLOWS:

<u>Section 1</u>. That Section 2-354, Article VIII of Chapter 2 of the Code of the City of Lake City, Florida, is hereby amended and as amended shall read in its entirety as follows:

Sec. 2-354. Budget Amendment procedure.

- (a) The city council, at any time within a fiscal year, may, by motion recorded in the minutes, amend a budget for that year as follows:
 - (1) Appropriations for expenditures in any fund may be decreased and other appropriations in the same fund correspondingly increased, provided that the total of the appropriations of the fund may not be changed.
 - (2) Appropriations from the reserve for contingencies may be made to increase the appropriation for any particular expense in the same fund, or to create an appropriation in the fund for any lawful purpose, but

expenditures may not be charged directly to the reserve for contingencies.

- (b) The city council, at any time within a fiscal year, may, by resolution, amend a budget for that year as follows:
 - (1) The reserve for future construction and improvements may be appropriated for the purposes for which the reserve was made.
 - and received for a particular purpose, including, but not limited to, grants, donations, gifts, or reimbursement for damages, may, by resolution of the city council, be appropriated and expended for that purpose, in addition to the appropriations and expenditures provided for in the budget. Such receipts and appropriations must be added to the budget of the proper fund. The resolution may amend the budget to transfer revenue between funds to properly account for unanticipated revenue.
- (c) Only the following transfers may be made between funds:
 - (1) Transfers to correct errors in handling receipts and disbursements.
 - (2) Budgeted transfers.
 - (3) Transfers to properly account for unanticipated revenue or increased receipts.
- (d) All unexpended balances of appropriations at the end of the fiscal year shall revert to the fund from which the appropriation was made, but reserves for sinking funds and for future construction and improvements may not be diverted

to other purposes.

- (e) Notwithstanding any other provisions in this section 2-354 of this article to the contrary, the city manager and city finance director are authorized and empowered during any fiscal year to transfer and reallocate within any department budget appropriations for expenditures provided for in the budget for any particular purpose, other than for capital expenditures and salary accounts, to accomplish any of the following purposes:
 - (1) To make transfers within a department's budget for the purpose of changing and reallocating appropriations for expenditures for any particular budgeted purpose within such department's budget to any other purpose so as to increase or decrease the appropriation for any particular expense in such department's budget; or
 - (2) To create an appropriation in such department's budget for any other lawful purpose, provided that the total budget for such department shall not be changed.
- (f) All such transfers and reallocated appropriations for expenditures made by the city manager and city clerk within each respective department budget authorized and permitted pursuant to subsection 2-354(e) shall be reported to the city council no less than quarterly during each fiscal year, detailing all transfers and reallocations that have been made and stating the reasons for such transfers and reallocations.

- (g) If an amendment to a budget is required for any purpose not specifically authorized otherwise in this article, unless otherwise prohibited by law, the amendment may be authorized by resolution of the city council.
- (h) The fiscal year of the city shall begin on the first day of October and end on the thirtieth day of September of each year.

Section 2. **Repeal**. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 3. Severability. Should any section, subsection, sentence, clause, phrase, or other provision of this ordinance be held invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionally shall not be so construed as to render invalid or unconstitutional the remaining provisions of this ordinance.

Section 4. Inclusion in the City Code. It is the intention of the City Council of the City of Lake City, Florida, that the provisions of this ordinance shall become and be made a part of the Code of the City of Lake City, Florida, and that the sections of this ordinance may be numbered appropriately in order to accomplish such intentions.

Section 5. Effective Date. This Ordinance shall take effect upon its adoption.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAKE CITY, FLORIDA, AUTHORIZING THE CITY TO ENTER INTO AMENDMENT NUMBER ONE TO BUILDING SPACE LEASE TO EXTEND THE TERM OF THE LEASE FOR AN ADDITIONAL TERM COMMENCING JULY 1, 2012, AND TERMINATING JUNE 30, 2013 FOR SPACE IN THE CITY'S PUBLIC SAFETY BUILDING TO HOUSE LIFEGUARD'S AMBULANCE AS AUTHORIZED BY CITY COUNCIL RESOLUTION NO. 2011-050.

WHEREAS, pursuant to Building Space Lease (the "Lease") as authorized by City Council Resolution No. 2011-050, the City of Lake City, Florida ("City") leased space in the City's Public Safety to Lifeguard Ambulance Service of Florida, LLC ("Lifeguard") for a term one (1) year terminating June 30, 2012; and

WHEREAS, Lifeguard has requested City to extend the Lease for an additional term of one (1) year commencing July 1, 2012, and terminating June 30, 2013, upon the same terms and conditions of the Lease; and

WHEREAS, City has determined that it is in the interest of the public to grant the extension to Lifeguard; and

WHEREAS, to memorialize the extension, City and Lifeguard desire to amend the Lease to provide for the one-year extension pursuant to and in accordance with Amendment Number One, copy of which is attached hereto as Exhibit "A" and made a part of this resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY
OF LAKE CITY, FLORIDA, AS FOLLOWS:

Section 1. The above recitals are all true and accurate and are incorporated

herein and made a part of this resolution.

Section 2. The City is hereby authorized to enter into Amendment Number One to extend the term of the Lease for an additional term of one (1) year commencing July 1, 2012, and terminating June 30, 2013, upon the same terms and conditions of the Lease granted by the City to Lifeguard authorized by City Council Resolution No. 2011-050. The Mayor is hereby authorized to execute Amendment Number One for and on behalf of the City.

<u>Section 3</u>. The City Clerk is instructed to provide Lifeguard with a copy of this resolution.

AMENDMENT NUMBER ONE TO BUILDING SPACE LEASE

THIS AMENDMENT NUMBER ONE TO BUILDING SPACE LEASE made and
entered into this day of, 2012, by and between the CITY OF
LAKE CITY, FLORIDA, a municipal corporation organized under the laws of Florida,
whose mailing address is 205 North Marion Avenue, Lake City, Florida 32055 (herein
"City"), and LIFEGUARD AMBULANCE SERVICE OF FLORIDA, LLC., a Florida limited
liability company, whose mailing address is 4211 Jerry L. Maygarden Road, Pensacola,
Florida 32504 (herein "Lifeguard").

RECITALS

- A. City and Lifeguard have heretofore entered into a Building Space Lease (the "Lease") dated June 27, 2011, as authorized by City Council Resolution No. 2011-050, wherein City granted to Lifeguard space in the City's Public Safety Building to house Lifeguard's ambulances and operate emergency medical services.
- B. The Lease was for a term of one (1) year commencing July 1, 2011, and terminating June 30, 2012.
- C. The parties desire to modify the Lease to provide for an additional term of one (1) year commencing July 1, 2012, and terminating June 30, 2012.

NOW, THEREFORE, it is mutually agreed as follows:

- 1. The recitals are true and correct and made a part of this amendment.
- 2. Paragraph 2 of the Lease is hereby amended to read as follows:



- 2. The term of the Lease is hereby extended for an additional one (1) year commencing July 1, 2012, and terminating June 30, 2013.
- 3. Except as amended herein, all other terms and conditions of the Lease shall remain in full force and effect.

An in-car camera is an essential tool in today's law enforcement world. The in-car camera collects and safely stores the data on internal memory. A video/audio recording can be utilized in criminal and civil court proceedings. Not only will the recordings be useful in complaints filed against an officer but also in the prosecution of D.U.I.'s, pursuits, use of force, citizens and their vehicles identification, etc. When an officer and a citizen know that their interaction is being both video and audibly recorded it assists in keeping both parties in check. These in-car camera recordings may be an invaluable source of information for civil law suits that may be brought against an officer and this agency.
