CITY COUNCIL RESOLUTION NO. 2018-089

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LAKE CITY, FLORIDA, FINDING AND DECLARING THE EXISTENCE OF AN EMERGENCY ARISING FROM AND OUT OF HURRICANE MICHAEL.

WHEREAS, the State of Florida and Nation have been made aware that Hurricane Michael may threaten the State of Florida and its various communities, including the City of Lake City, and endanger the safety and welfare of the citizenry and their property; and

WHEREAS, based upon information, advices and warnings from the various appropriate weather agencies, the City, in order to protect the welfare and safety of the citizens of the City and their property, finds it necessary to declare the existence of an emergency and to make all precautionary and necessary plans to avoid and/or minimize damages arising from and out of Hurricane Michael.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LAKE CITY, FLORIDA, AS FOLLOWS:

Section 1. The City hereby finds and declares the existence of an emergency arising out of and from Hurricane Michael and authorizes and instructs all of the City officials and the various departments of the City to take all emergency

action which is prudent and necessary to protect the welfare and safety of the citizens of the City and their property.

Section 2. The City Manager is hereby authorized to make emergency purchases of supplies and services required to prevent or repair damages resulting from Hurricane Michael.
