

# INVITATION TO BID ITB-018-2014

Sealed bids will be accepted by the City of Lake City, Florida until **Tuesday, April 1, 2014 at 11:00 a.m.** local time in the Procurement Department located on the 2<sup>nd</sup> floor of City Hall, 205 N Marion Avenue, Lake City, Florida 32055. Any bids received after the above time will not be accepted under any circumstances. Any uncertainty regarding the time a bid is received will be resolved against the Bidder. Bids will not be accepted via fax. Bid opening will be promptly at **11:15 a.m.** in the City Council Chambers located on the 2<sup>nd</sup> floor of City Hall, at which time all bids will be publicly opened and read aloud for:

#### CLEANING AND PAINTING EXTERIOR OF 500,000 GALLON ELEVATED TANK

All bid proposals which are submitted through delivery services such as Federal Express, UPS, or United States Postal Service Express Mail, must be marked on the OUTSIDE of the delivery package with the company or Bidder's name, address, phone number, bid number (ITB-018-2014), bid title (CLEANING AND PAINTING EXTERIOR OF 500,000 ELEVATED TANK) the date and time (April 1, 2014 at 11:00 a.m.). The bid proposal must be in a sealed envelope INSIDE the delivery package with the same information as listed above. All bid proposals which are hand delivered or delivered through regular mail by the United States Postal Service must have all the same information as listed above on the OUTSIDE of the sealed envelope. Failure to comply may be reason to reject the bid.

One (1) original plus one (1) copy of your bid must be sealed and plainly marked on the outside of the envelope with the bid number, the bid name and opening date. Bids must be addressed to the following:

Bids must be completed in English language, signed with ink, in spaces provided on the enclosed bid forms and submitted in duplicate or bid will be subject to rejection.

Any deviation from the specifications must be explained in detail on sheets attached to the bid form and labeled "Clarifications and Exceptions," and each deviation must be itemized by number and must specifically refer to the applicable specification paragraph and page.

Otherwise it will be considered that items offered are in strict compliance with these specifications and the successful Bidder will be held responsible for meeting the specification. All questions must be in writing and directed to the Director of Procurement. All questions will be answered in writing. Any answers which may alter the scope of work will be answered in the form of addenda. Any and all Addenda must be signed and returned with the original response to be considered responsive. Deadline for receiving questions is **Tuesday, March 25, 2014 at 4:00 P.M.** Questions received after this date and time will not be considered. Questions may be submitted via e-mail to **procurement@lcfla.com** or by mail to City of Lake City, Procurement Department, 205 N. Marion Avenue, Lake City, FL 32055.

Bidder may not withdraw his/her bid for a period of sixty (60) days.

The City of Lake City is exempt from State Use Tax, State Retail Tax and Federal Excise Tax. The bid price must be net, exclusive of taxes. Bidder's proposal must be dated, signed by authorized representative, title, firm name, address and telephone number.

Local Vendor Preference: City of Lake City Administrative Policy #18 states that the bid of a resident of Columbia County, Florida will have a 5% preference over the bid submitted by any non-resident of Columbia County. A resident is defined as an individual whose primary residence is within Columbia County, Florida, a partnership whose principals are all residents of Columbia County, Florida, partnership or other business entity whose principal place of business is within Columbia County, Florida, or which maintains a full time business office open to the public within Columbia County, Florida. With these and other contributing factors the City Council reserves the right to award a bid or contract in the best interest of the City.

Respondents to this solicitation or persons acting on their behalf may not contact, between the release of the solicitation and the end of the 72-hour period following the agency posting the notice of intended award, excluding Saturdays, Sundays, and city holidays, any employee or officer of the executive or legislative branch concerning any aspect of this solicitation, except in writing to the Procurement Department or as provided in the solicitation documents. Violation of this provision may be grounds for rejecting a response.

Any Bidder desirous of protesting a bid for any reason must file a written notice of bid protest with the City Manager's office within 72 hours following posting of notice of intended award. All protest will be in writing stating the bid being protested and the specific reason of the protest. All protest will be signed by the Protestor and include all detail for a complete and thorough review. The decision of the City Manager, after consultation with the City Attorney will be issued within five (5) working days of the receipt of the protest, unless additional time is agreed upon by all parties involved should circumstance warrant such a delay.

By submission of his/her bid, the Bidder certifies that:

A. The bid has been arrived at by the Bidder independently and has been submitted without collusion with any other vendor of materials, supplies or equipment described in the Invitation to Bid.

B. The contents of the bid have not been communicated by the Bidder, his/her employees or agents, to his/her best knowledge and belief, to any person not an employee or agent of the Bidder or his surety in any bond furnished herewith and will not be communicated to any such person prior to the official opening of the bids.

The City of Lake City reserves the right to accept or reject any/all bids and to award the contract in the best interest of the City of Lake City, Florida.

#### "SCOPE OF WORK"

SEALED BIDS WILL BE ACCEPTED BY THE CITY OF LAKE CITY FOR THE CLEANING AND PAINTING OF THE EXTERIOR OF 500,000 GALLON ELEVATED TANK, EAST OF DOWNTOWN, LOCATED SOUTH OF US 90 AND MURRAY STREET, LAKE CITY, FLORIDA. THE CONTRACTOR WILL PROVIDE PARTS, LABOR, MATERIALS, AND EQUIPMENT NECESSARY TO CLEAN, PREP, AND PAINT THE EXTERIOR OF 500,000 GALLON, 140-FOOT HIGH LEGGED ELEVATED TANK.

# Proposal must include:

- 1. Exterior of tank shall be steam cleaned (top to the bottom) with 4000 PSI pressure washer using United Weather-Zyme 727 cleaner, or equivalent, for the destruction of mildew spores and removing atmospheric carbons. Mixture shall be 1-part cleaner, 3-parts chlorine, and 1-part water.
- 2. Exterior tank shall be power steam rinsed (top to the bottom) with hot water.
- 3. Power tool all rusting areas using 3M pads or equivalent.
- 4. Spot prime with Tnemec Series 135 Epoxy paint, 3-5 DFT.
- 5. Apply two (2) full coats of Tnemec Spray Safe Series 30, 3-5 DFT per coat.
- 6. Repaint Logos, as is, with Tnemec Series 1074 UV Urethane coating.

#### TERMS AND CONDITIONS

# A. LICENSES/QUALIFICATIONS:

1. All Contractor's together with any Sub-Contractor's must be qualified and licensed under the laws, rules and regulations of the State of Florida and the City of Lake City, Florida to perform the work required by these contract documents. Contractor's qualifications including equipment to be used for this project will be subject to review and approval by the City prior to award of quote. Contractor must be prepared to demonstrate, through previous experience and references, the ability to safely and successfully perform this size and type of directionally drilled pipeline project.

# B. <u>INSURANCE:</u>

- 1. Without limiting Contractor's indemnification, it is agreed that the successful Contractor will purchase at their own expense and maintain in force at all times during the performance of services under this agreement the following insurance. Where specific limits are shown, it is understood that they must be the minimum acceptable limits. If successful Contractor's policy contains higher limits, the City of Lake City will be entitled to coverage to the extent of such higher limits. Certificates of Insurance must be furnished to the City naming the City of Lake City as additional insured. These certificates must provide a ten (10) calendar day notice to the City in the event of cancellation, non-renewal or a material change in the policy. Any deductibles will be the sole responsibility of the Contractor. The City of Lake City must be exempt from, and in no way liable for, any sums of money which may represent a deductible in any insurance policy. The payment of such deductible must be the sole responsibility of the Vendor/Contractor and/or subcontractor providing such insurance.
- 2. Statutory Workers Compensation insurance as required by the State of Florida.
- 3. Commercial General Liability insurance to provide coverage of not less than \$1,000,000.00 combined single limit per occurrence and annual aggregates where generally applicable and must include premises-operations, independent contractors, products/completed operations, broad form property damage, blanket contractual and personal injury endorsements.
- 4. Comprehensive Automobile Liability Insurance covering all owned, hired and non-owned vehicles with coverage limits not less than \$100,000.00 per person, \$300,000.00 per occurrence and \$100,000.00 property damage.

# C. INDEMNITY:

1. Successful Contractor will indemnify and hold the City of Lake City and City's agents (engineer, surveyors, etc.) harmless from any loss, cost, damage or injury

sustained by any persons (s) as a result of the actions of employees or officers of the Contractor, Sub-Contractors or suppliers.

#### D. LIQUIDATED DAMAGES:

1. In the event the Bidder is awarded the contract and fails to complete the work within the time limit or extended time limit agreed upon, liquated damages will be paid to the City of Lake City at an amount not to exceed actual damages incurred by the City per day.

# E. SPECIAL CONDITIONS:

- 1. Extended time may be allowed for the completion of this project due to inclement weather.
- 2. Decisions to allow days added to the contract due to inclement weather will be based upon weather records as recorded with the State of Florida, Division of Forestry located in Lake City, Florida and approved by the Executive Director of Utilities.
- 3. In the event additional days are awarded the contractor must notify the City of Lake City Procurement department at the beginning of work stoppage and each succeeding day until work can be safely resumed.

# F. <u>CONTRACT:</u>

1. The successful Contractor will execute the contract within ten (10) calendar days after Notice of Award. Upon receipt of all required documents, a Notice to Proceed will be issued.

# G. SCHEDULE:

- 1. The successful Contractor must commence work within sixty (60) calendar days of issuance of Notice to Proceed.
- 2. The successful Contractor must complete all work within sixty (60) calendar days after commencement of project.

#### H. PAYMENT:

1. Payment for work completed will be based on: (a) City's acceptance of work, and (b) submitted evidence satisfactory to the City that all payrolls, materials, bills, and indebtedness connected with the work have been paid. The City may withhold an amount as may be necessary to pay such claims for labor and services rendered and materials involved with the work. It is the expectation of the City that one invoice will be submitted by the Contractor upon completion and

acceptance of work. Payment to Contractor will be made within thirty (30) calendar days of receipt of invoice, assuming there are no contested amounts with the invoice.

# I. <u>EXPERIENCE/REFERENCES:</u>

- 1. Contractor must include information on similar projects.
- 2. Bidders must include on the form provided and with their proposal substantial material for evaluating the ability of the potential Bidder to execute a project of this type. Therefore, the Bidder is required to provide a minimum of three (3) references for painting elevated water tanks in the last twelve (12) months. The list of references must be attached with the bid proposal on the form provided within these specifications. All reference materials provided become the property of the City of Lake City and also become public record.

#### J. PAYMENT AND PERFORMANCE BONDS:

1. Payment and performance bonds are not a requirement of this bid.

# K. CHANGE ORDERS:

- 1. Notify the City of Lake City of any conditions in the project area that are not addressed within the specifications which may require a change order.
- 2. Change orders to the scope of work or additional work requested by the City of Lake City must be in written form, initiated by the contractor.
- 3. All changes or additions will be approved by the City of Lake City prior to work being initiated.

# L. ADDENDUM:

It will be the sole responsibility of the bidder to contact the Procurement Department prior to submitting a bid to determine if any addenda have been issued, to obtain such addenda, and to acknowledge addenda with their bid. Failure to submit acknowledgement of any addendum that affects the bid price is considered a major irregularity and will be cause for rejection of the bid.

# M. OR APPROVED EQUAL:

1. Any Bidder proposing products manufactured other that stated in these bid specifications must provide all product data no later than fourteen (14) calendar days prior to the bid opening date of **April 1, 2014**. A determination of acceptability will be made by the City and conveyance thereof to said vendors prior to bid opening date by form of addenda.

# N. <u>REQUIRED DOCUMENTS:</u>

1. The enclosed documents must be executed and returned with bid proposal or the proposal may be considered non-responsive. (Conflict of Interest Statement, Disputes Disclosure Form, Drug Free Workplace Certificate, Non-Collusion Affidavit of Proposer, Reference, Public Entity Crime Statement and E-verify Affirmation Statement.)

#### O. WARRANTY:

1. Provide a one (1) year warranty with an anniversary inspection at eleven (11) months after the completion of the project to identify and repair any coating problems.

# P. EMPLOYMENT ELIGIBILITY VERIFICATION (E-VERIFY)

In accordance with State of Florida, Office of the Governor, Executive Order 11-1. 116 (superseding Executive Order 11-02; Verification of Employment Status), in the event performance of this Agreement is or will be funded using state or federal funds, the CONTRACTOR must comply with the Employment Eligibility Verification Program ("E-Verify Program") developed by the federal government to verify the eligibility of individuals to work in the United States and 48 CFR 52.222-54 (as amended) is incorporated herein by reference. If applicable, in accordance with Subpart 22.18 of the Federal Acquisition Register, the CONTRACTOR must (1) enroll in the E-Verify Program, (2) use E-Verify to verify the employment eligibility of all new hires working in the United States, except if the CONTRACTOR is a state or local government, the CONTRACTOR may choose to verify only new hires assigned to the Agreement; (3) use E-Verify to verify the employment eligibility of all employees assigned to the Agreement; and (4) include these requirement in certain subcontracts, such as construction. #### Q. PUBLIC RECORD:

- 1. The Owner is a public agency subject to Chapter 119, Florida Statutes. The Contractor shall comply with Florida's public records law. Specifically, the Contractor shall:
  - a. Keep and maintain public records that ordinarily and necessarily would be required by the Owner in order to perform the service;
  - b. To Provide the public with access to such public records on the same terms and conditions that the Owner would provide the records and at a cost that does not exceed that provided in Chapter 119, Florida Statutes, or as otherwise provided by law;

c. Ensure that public records that are exempt or that are confidential and exempt from public record requirements are not disclosed, except as authorized by law; d. Meet all requirements for retaining public records and transfer to the Owner, at no cost, all public records in possession of the Contractor upon termination of the contract and destroy any duplicate public records that are exempt or confidential and exempt. All records stored electronically must be provided to the Owner in a format that is comparable with the information technology systems of the Owner.

# R. <u>ADDITIONAL INFORMATION:</u>

1. The City of Lake City Procurement Department reserves the right to request any additional information needed for clarification from any Bidder for evaluation purposes.
